
Feedback Analysis:


The feedback regarding the syllabus is collected from various stakeholders like students, teachers, parents, ex-students and experts. Total 10 objective type questions covering various aspects of the syllabus were asked in the feedback. The questions are as following:


- 1. Is the content of syllabus understandable?
- 2. Is the syllabus useful to inculcate employment and Entrepreneurship?
- 3. Does the syllabus develop skills and research aptitude?
- 4. Does the syllabus develop innovation and life skills?
- 5. Is the syllabus useful in real life situation?
- 6. Does the syllabus support for personality development?
- 7. Is the syllabus relevant and timely with the present era?
- 8. Is the syllabus useful for getting admission for PG?
- 9. Does the syllabus add values of environment awareness?
- 10. Does the syllabus add values of Social Responsibility?

Three options (Yes, No and Uncertain) were given to each question to register the feedback. The feedback is analyzed by using Percentile method.











Ex-Students' Feedback








Parent's Feedback






85% parent rate positive remark of the usefulness of the syllabus to inculcate employment and entrepreneurship..


It is the opinion of the 90% parents that the syllabus develops skills and research

86% parents cherish that the syllabus helps for developing innovation and life skills among the students.


Parents have positive attitude towards the syllabus regarding usefulness of syllabus in real life situation.





Experts' Feedback

The experts unanimously stated that the syllabus is understandable.


There is drift among the experts regarding the usefulness of syllabus to inculcate employment and entrepreneurship. Only 53% experts rate the syllabus positively on this perspective.


Nearly half of the experts find that the syllabus is not useful to develop skills and research aptitude.

A notable number of experts have registered negative reply for the quality of syllabus to develop innovation and life skills among e students.

25% experts are pessimistic and 11% experts are unsure about the application of syllabus in real life situation.







1. Feedback regarding the content of syllabus :



All the stakeholders have stated that the content of the syllabus is understandable.

2. Feedback regarding usefulness of syllabus to inculcate employment and Entrepreneurship:

Students and parents feel that the syllabus is useful to inculcate employment and entrepreneurship. On the other hand, teachers and experts feel that the syllabus is not useful for it. Ex-students are uncertain about it.

3. Feedback regarding usefulness of syllabus to develop skills and research aptitude:

The students and parents have positive reply for the usefulness of syllabus to develop skills and research aptitude but teachers and experts are inclined towards negativity for this quality of syllabus. Ex-students are uncertain about it.

4. Feedback regarding the usefulness of syllabus to develop innovation and life skills:

Students and parents accept that the syllabus helps to develop innovation and life skills. Teachers feel that syllabus is unhelpful for it. The opinions of experts and ex-students are uncertain or slightly negative.

5. Feedback regarding usefulness of syllabus in real life situation:

Only parents support that the syllabus is useful in real life situation. All other stakeholders have negative or slightly negative remark for the usefulness of syllabus in real life situation.

6. Feedback regarding support of syllabus for personality development:

Except parents, all other stakeholders reject that the syllabus supports for personality development.

7. Feedback showing the syllabus relevant and timely with the present era:

Teachers, Experts and Ex-students indicate that the syllabus in not relevant and timely with the present era. Students are uncertain about it but parents accept that the syllabus is relevant and timely with present era.

- Compartant 8. Feedback regarding usefulness of syllabus for getting admission in PG: Cent-percent stakeholders have confirmed that the syllabus helps to got instant admission in PG.
- 9. Feedback regarding the usefulness of syllabus for adding values of environment awareness:

Teachers and Experts have confirmed but students, ex-students and parents are uncertain that the syllabus is useful for adding values of environment awareness.

10. Feedback regarding the usefulness of syllabus for adding values of Social **Responsibility:**

Except parents, all other stakeholders have indicated that the syllabus either lack the quality or uncertain regarding the use of syllabus for adding values of social responsibility.
