- 4) To get Practices of Interview technique, Interview-Scheduled etc. as the part of the methods of data collection.

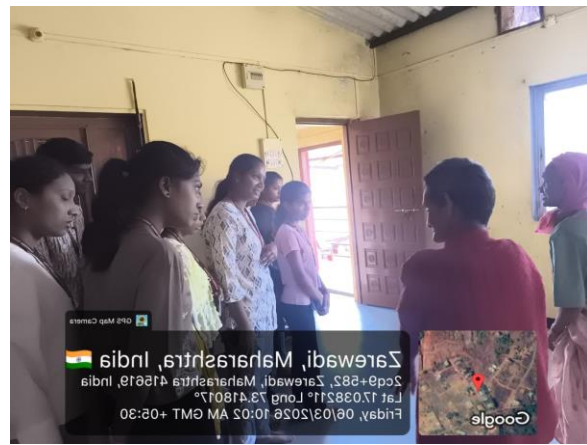


## Outcomes:
